**Promotion Terms:** 



The Promotion Details and the Promotion Terms together form the terms and conditions of entry for the Promotion (**Terms and Conditions**). By participating in this Promotion each entrant accepts and agrees to be bound by these Terms and Conditions.

To the extent of any inconsistency between the Promotion Details and the Promotion Terms, the terms of the Promotion Details will prevail. Capitalised terms not otherwise defined in these Promotion Terms have the same meaning as in the Promotion Details.

The promoter is Moonee Valley Racing Club Inc. (ABN 45 806 588 917) of Gate 1, McPherson Street, Moonee Ponds, Victoria 3039 (**Promoter**).
