Ladbrokes 2019 Punters Club – Moonee Valley Racing Club

Terms and Conditions

- 1. The promoter is GVC Australia Pty Ltd T/A Ladbrokes, ABN 25 151 956 768, of 461-473 Lutwyche Road, Lutwyche Queensland, 4030. (**Promoter**). The Promoter and its related companies are referred to as the **Promoter Group**.
- 2. Instructions and information on how to enter the promotion form part of these terms and conditions, and entry into the promotion is deemed acceptance of these terms and conditions and all of the Promoter's terms and conditions.
- 3. Entry to the promotion is open from half an hour prior to the first race and concludes on completition of the final race at Moonee Valley Racing Club, on 7 September 2019 (**Promotion Period**).
- 4. Entry to the promotion is free. Entry is open to residents of QLD, VIC, ACT, TAS & NT who are 18 years of age or older and who have purchased a ticket into the Ladbrokes Punters Club Function, held in the Champions Room at Moonee Valley Racing Club and who hold a valid Ladbrokes account.
- 5. The following people are not eligible to win any prizes resulting from this promotion:
 - a) directors, managers, agents, employees of the Promoter Group and their immediate families;
 - b) directors, managers or employees of businesses associated with the promotion, including Moonee Valley Racing Club; and
 - c) an entrant whose betting account with the Promoter Group is either suspended or inactive due to a Responsible Gambling concern or for another reason.
- 6. To enter, entrants must provide their Ladbrokes account username, name, mobile number and email address on the booking form at the time of booking.
- 7. Each entrant will receive a \$100 Ladbrokes Bonus Bet in their Ladbrokes account for use during the Punters Club. The Bonus Bet is subject to terms and conditions available at www.ladbrokes.com.au/terms-and-conditions/.
- 8. The prize for the promotion is \$500 AUD in cash deposited into the prize winners' account.
- 9. In the event of a tie, the prizes may be split.
- 10. If a prize is not available for any reason, the Promoter reserves the right to substitute the prize for another of similar value.

- 11. The winner of the prize will be the entrant who achieves the largest win or smallest loss (by percentage, not dollar amount) in their Ladbrokes betting account from the Bonus Bet and other stakes over the duration of the Promotion Period. For example, an entrant who wins \$50 from stakes of \$10 (500%) during the Promotion Period will win over a person who wins \$20,000 from stakes of \$10,000 (200%) during the Promotion Period.
- 12. The winner will be determined by the Promoter on 7 September 2019 after the Promotion Period ends.
- 13. The Promoter's decision as to the result of the promotion is final and no correspondence will be entered into.
- 14. The Promoter will attempt to notify the prize winners by 6:00pm on 7 September 2019 by announcing the winner at the Ladbrokes Punters Club Function and via SMS to the mobile supplied upon entry. The Promoter may also announce or publish the first name, surname and suburb or town of the prize winners in any media, including the Promoter's website and social media. Moonee Valley Racing Club may also announce or publish the first name, surname and suburb or town of the prize winners on social media.
- 15. The prize will be deposited to the prize winner's Ladbrokes account within 48 hours of being determined.
- 16. The right to a prize is not transferable or assignable to another person, or redeemable for cash.
- 17. The Promoter reserves the right, at any time, to verify the validity of any entry or disqualify any entrant who submits an entry that is not in accordance with these terms and conditions or who tampers with the entry process. The decision to verify, validate or disqualify an entry is in the Promoter's absolute discretion.
- 18. If the Promoter reasonably considers that a change to these terms and conditions is likely to benefit entrants or be immaterial detriment to entrants, then the Promoter can make the change immediately and does not need to notify entrants. Alternatively, the Promoter may vary these terms and conditions by placing a notification at all places where these terms and conditions are made available to entrants.
- 19. No responsibility is accepted for late, lost or misdirected entries. The Promoter is not responsible for any problems or technical malfunction of any computer system, software or internet difficulties, including any damage to an entrant's device, resulting from participating in the promotion. Any cost associated with participating in the promotion are the entrant's responsibility.
- 20. The Promoter will not be liable for any loss or damage or personal injury suffered or sustained in relation to the promotion or a prize except for any liability which cannot be excluded by law.
- 21. If the Promoter is prevented from or delayed in performing an obligation by Force Majeure then the obligation is suspended during, but for no longer than, the period the Force

Majeure continues and any further period that is reasonable in the circumstances. 'Force Majeure' means any event beyond the reasonable control of the Promoter, which occurs without the fault or negligence of the Promoter.

- 22. Subject to obtaining the approval from the regulator (if applicable), the Promoter reserves the right to delay or modify any aspect of this promotion if for any reason it is not capable or running as planned (including without limitation, by reason of infection by computer virus, bugs, tampering, fraud, technical failures, power failures or due to any other causes unforeseen or beyond the reasonable control of the Promoter which corrupt or affect the administration, security, fairness, integrity or proper conduct of the promotion) but only to the extent necessary to overcome the issue that is affecting the running of the promotion as planned.
- 23. By participating in the promotion, an entrant authorises the Promoter Group, and contractors and agents of the Promoter Group, to access, collect and use personal information about the entrant, and disclose personal information about the entrant, to the Promoter Group and its contractors and agents, for the purposes of (i) conducting the promotion and (ii) providing the entrant with information about products and services of the Promoter Group; and (iii) making arrangements for a prize winner to be notified and receive their prize. Such information may be provided electronically, or by contacting the entrant by telephone or other means, until such time as the entrant asks the Promoter not to provide further information. The Promoter's Privacy Policy (available at www.ladbrokes.com.au/terms-and-conditions/) contains information about how to access, correct or make a complaint about the Promoter's handling of personal information. A prize winner may be asked by the Promoter to participate in publicity associated with the promotion. The prize winner will have the right to elect whether or not to participate in that publicity.

If an entrant does not provide the personal information requested, the entrant cannot participate in the promotion and will not receive information about products and services of the Promoter Group.
